The Direction of Travel document was then discussed as a starting point to engage stakeholders and members were keen to be kept informed and a Members' briefing is planned for January 9th 2024. I have two consecutive planning meetings Wednesday and Thursday followed by a Members' briefing at Arun regarding the financial situation of the Council and possible savings to consider. I have also attended a Chief Executive Remuneration panel to consider salary to be offered and both Arun sessions at Bersted Community Centre which proved to be very useful.
